### **Processing framework and origin of the data**

Purpose and legal basis for processing Art. 6, paragraph 1, lit. a, b, c, f GDPR

---

#### **Supplier data:**

Personal data is collected, processed or used to fulfill the business purpose of ordering offers, order confirmations, invoices, goods and services and maintaining business contact and information from the supplier ( Art. 6 Para. 1 lit. a, b, f EU -GDPR). In addition, we may also process your data to exercise house rights (video surveillance of public spaces in accordance with Art. 6 Para. 1 f) GDPR ivm . § 26 paragraph 1 BDSG-new . Furthermore, there is a legal obligation to process, e.g. due to tax regulations (Art. 6 Para. 1 lit. c EU-DS-GVO).

Categories of personal data processed:

#### **Essential data categories are:**

- Surname
- address
- Contact details of contact persons in the company (first name, last name)
- Communication data (telephone number, mobile number, email address, fax number)
- Customer number as well as order and delivery data for the purpose of initiation

- Order and contract data
- Billing and payment data (bank details)

## Origin (source) of the data

---

The stored data was collected as part of our contractual relationship and for the initiation of contracts and individual orders, or they arose in the context of business relationships and business initiation. The data is stored to fulfill and process the orders placed with us as well as the commercial and tax documentation and archiving obligations.

## Recipients (categories) of the personal data

---

**External bodies** (contractual partners) insofar as these are necessary for the fulfillment of the contract. External contractors (service companies) in accordance with Art. 28 GDPR to process the data on our behalf:

**Other external bodies** : companies belonging to the group or other external bodies for the fulfillment of the above-mentioned purposes, insofar as the person concerned has given his written consent, this is necessary for the fulfillment of the contract or a transmission is permissible due to an overriding legitimate interest:

- credit institution
- tax consultant
- insurances
- Schufa
- Lawyer

## Transfer to third countries

---

In individual cases, data will only be transmitted on the basis of an adequacy decision by the European Commission, standard contractual clauses, suitable guarantees or your express consent.

## Duration of storage / deletion

---

10-year	annual financial statements, opening balance sheets, trading and business books, records, work instructions, organizational documents, invoices and accounting documents (HGB, AO, EStG, KStG, GewStG, UStG, AktG, GmbHG, GenG)
6 years	commercial and business letters as well as for other documents (HGB, BGB)
30 Years	Enforceable Titles

### The following data will be deleted in accordance with Art. 17 GDPR:

- If the storage of the data is no longer necessary
- If the data subject has revoked their consent to data processing
- If the data has been processed unlawfully
- If there is a legal obligation to delete under EU or national law

### Restriction of processing pursuant to Article 18

If deletion is not possible in the case of non-automated data processing due to the special type of storage or only with a disproportionate amount of effort and the interest of the data subject in deletion is to be regarded as low, the data subject has the right and the obligation of the person responsible for deletion personal data according to Article 17 paragraph 1 of Regulation (EU) 2016/679 in addition to the exceptions mentioned in Article 17 paragraph 3 of Regulation (EU) 2016/679. In this case, the restriction of processing in accordance with Article 18 of Regulation (EU) 2016/679 takes the place of deletion. Sentences 1 and 2 do not apply if the personal data has been processed unlawfully.

## rights of the data subject

---

- Information about the data stored about you (Article 15 GDPR). In particular, you can obtain information about the processing purposes, the category of personal data, the categories of recipients to whom your data has been or will be disclosed, the planned storage period, the existence of a right to correction, deletion, restriction of processing or objection, the existence of a Right to complain, the origin of your data, if not collected from us, and the existence of automated decision-making including profiling and, if necessary, meaningful information about their details.
- Correction - Should incorrect personal data be processed (Article 16 GDPR),
- Deletion and restriction as well as objection to processing (Articles 17, 18 and 21 GDPR).
- Right to data transfer (Art. 20 GDPR, to receive your personal data that you have provided to us in a structured, common and machine-readable format or to request transmission to another person responsible.
- Revocation of consent (Art. 7 Para. 3 GDPR). As a result, we are no longer allowed to continue the data processing based on this consent for the future

- Right of appeal to the competent supervisory authority (Article 77 GDPR)

## right to object

---

If your personal data is based on legitimate interests in accordance with Art. 6 Para. 1 S. 1 lit. f DSGVO are processed, you have the right to object to the processing of your personal data in accordance with Art. 21 DSGVO, provided that there are reasons for this that arise from your particular situation or the objection is directed against direct advertising. In the latter case, you have a general right to object, which we will implement without specifying a particular situation.

## Right to withdraw consent

---

Each person concerned has, within the meaning of Art. 6 Para. 1 lit. a or Art. 9 Para. 2 lit. a the right to revoke individual or all consents that were granted, for example, for the fulfillment of the contract at any time and without disadvantages for yourself, without affecting the legality of the processing carried out on the basis of the consent up to the revocation.
